DIRECTIONS FOR USE:

- **CARPETING:** To deodorize urine & waste stains, use at 1:1 spray on affected areas. May also be added to extraction water.
- **GREASE TRAP:** At a non-use period, pour an initial dose of one (1) pint into opening closest to grease trap. After adding, flush with a cup of lukewarm water to aid in digestion. Thereafter use 4 - 8 oz. daily depending on size of trap.
- **FULL GARBAGECANS & TRUCKS:** Use full strength. Spray on and allow to penetrate matter.
- **PORTABLE TOILETS & OUTHOUSES:** Use as is from 1 qt. - 1 gal. to aid in digestion & odor control.
- **WASTE & PUMP STATIONS:** Use 1 pint per 50 gal. tank capacity.

DIRECTIONS CONTINUED:

- **SEPTIC TANKS:** Add one (1) pint initially in to toilet & flush. Thereafter use 8 oz. per week for maintenance. If septic tank is clogged and is emitting odors, pour one (1) gal. directly into the tank through the manhole.
- **LAGOONS AND WASTE WATER PLANTS:** 1 gal. for each 10,000 gal. capacity.
